- 1. Intervention Plan/Instructions: I will participate in the development of and comply with a rehabilitation plan designed by my community supervision officer. This plan will require me to work, to be drug tested, and may require me to attend and to pay a reasonable fee for counseling or classes. I will truthfully answer all questions and follow all written and verbal instructions from my community supervision officer or any other community supervision officer or any employee of the Department of Community Supervision or the State Board of Pardons and Paroles.
- 2. Law/ Immediate Notification/Searches: I will not violate the law of any governmental unit. I will immediately notify my community supervision officer if I am arrested for any offense, including a traffic offense. My community supervision officer or any other community supervision officer may, at any time, conduct a warrantless search of my person, papers, and place of residence, automobile, or any other property under my control.
- 3. Weapon: I will not receive, possess, transport, have under my control, attempt to purchase, or obtain transfer of any firearm, ammunition, explosives or other deadly weapons.
- **4. Leaving State and Absconding:** I will not leave my state of residence, even briefly, or change my residence without first getting permission from my community supervision officer. I will not abscond from parole supervision.
- **5.Child Support, Restitution, and Fees:** I will support all my children as required by Georgia law, make payments on any restitution, pay a monthly parole supervision fee as established by Parole Board rule, and pay a reasonable fee for electronic monitoring.
- **6.Education:** If I do not have a high school diploma or its equivalent and am unable to maintain reliable, regular employment, I will attend school to pursue a general education diploma (GED), a high school diploma, or a trade at a vocational/technical school.
- 7. Terms of Probation: If serving a split sentence, I will abide by all terms of probation imposed by the sentencing court(s).

#### ACKNOWLEDGMENT AND CERTIFICATION

I have read or have had read to me the above standard Parole conditions and any special conditions on the front side of this certificate, and fully understand them and agree to comply with them. I hereby waive all extradition rights and process and agree to return to Georgia from any State or Territory of the United States or from the District of Columbia. ## SPECIAL CONDITIONS OF SUPERVISION

I hereby agree to comply with the following special conditions of my release.

- A. I will not purchase or possess any pornographic or sexually explicit materials including but not limited to: adult over the counter publications, underground publications, privately developed materials, adult cable stations and sexually-explicit computer software.
- B. I will not frequent or be employed by any business exhibiting pornographic materials or activities, including but not limited to adult bookstores, theaters, and nude/strip bars and clubs.
- C. I will have no physical, written, visual or telephone contact with the victim(s) in the offense(s) unless specifically approved by my Community Supervision Officer, the treatment provider(s) and the victim(s).
- D. I will receive and pay for a sex offender assessment by an agency approved treatment provider and participate in and pay for any treatment and/or counseling deemed necessary by the Parole Board and my Community Supervision Officer. I will continue in treatment for the duration of parole unless my Community Supervision Officer, in consultation with the treatment provider, instructs me that I have completed treatment.
- E. I will not visit/access pornography sites or chat rooms on the Internet and I will consent to and permit periodic inspections by my Community Supervision Officer of my computer or any other device possessed by me that has Internet capabilities to determine if I have used the Internet in any manner proscribed. I will not use the Internet to view or distribute lewd photos of anyone under 18 years of age; nor will I, without prior permission from my Community Supervision Officer, befriend, monitor, communicate with, or gather information about anyone under 18 years of age through use of the Internet.
- F. I will not use or consume any controlled substance or mind altering drug including alcohol, except pursuant to a legal doctor's prescription. I will inform my Community Supervision Officer the next business day of any prescription I receive from a doctor.
- G. I will submit to, and if necessary pay for, breath, urine, blood or saliva testing to check for the presence of any prohibited drug and/or alcohol in my body.
- H. I will submit to and truthfully answer all questions asked during a polygraph assessment and evaluation regarding my behavior as instructed by Parole Board and/or my Community Supervision Officer. I will also pay a reasonable fee for this examination.
- I. I will not engage in any form of sexual contact, or abusive activity, with anyone under 18 years of age; or with anyone who is unable to give consent due to mental or emotional limitations.
- J. I will live only in a residence approved by my Community Supervision Officer and agree not to live or share a residence with any other person with a history of a sexual offense conviction (residential treatment facilities are exempted). The location of my residence and employment will comply with Georgia Law and/or any other condition imposed by the Board. I may not be employed at a location within 1000 feet of, nor be employed by, a child care facility, school, or church. If required by law, I must register with the local sheriff's office in the county(s) of my residence. I must annually update or verify my sex offender registration information with the sheriff's office in the county of my residence 72 hours prior to my date of birth and, if required by law, pay a \$250 registration fee. I will not move without first receiving permission from my Community Supervision Officer. I must report any changes in my residence to the appropriate sheriff's office within 72 hours before the change and, if moving to another county, within 72 hours after the change to the new sheriff's office. Changes in employment and/or educational attendance must be reported to the appropriate sheriff's office within 72 hours of the change.
- K. I will attend, participate in, and pay for mental health, anger, and/or violence prevention counseling if instructed by my Community Supervision Officer.
- L. I will not associate with prostitutes and will avoid areas known to have prostitution activity.
- M.I will work only at places pre-approved by my Community Supervision Officer.

- N. I will not be with any child under 18 years of age unless an adult is present who has knowledge of my history of criminal sexual behavior and/or abusive behavior and who has been approved in writing as a chaperone by my Community Supervision Officer.
- 0. I will not reside in any residence, either permanently or temporarily, with persons under 18 years of age unless the child is my biological or adopted child and I have lawful custody or court approved visitation rights for said child. I will not work and/or volunteer for any business, organization or activity which provides services or care to children under 18 years of age or to persons over 18 years of age who are unable to give consent due to mental or emotional limitations.
- P. I will not have any contact with anyone under 18 years of age whether in person or through any means of communication; nor will I attend any place of business, amusement, social event, or gathering of any type for the purpose of coming in contact with minors. Except as authorized by the Parole Board or my Community Supervision Officer, I will not create, possess, access or control any type of photograph, video, rendering or digital imagery of any person under 18 years of age.
- Q. I will submit a schedule of weekly activities to my Community Supervision Officer, if requested; and will abide by any curfew placed on me by my Community Supervision Officer.
- R I will remain fully and appropriately clothed, and will not engage in lewd behavior, when in public or when potential for public view exists.
- S. I am prohibited from working or volunteering in the following types of business, organizations, or activities:
  - 1. Schools

7. Driving a school or youth bus

2. Day care centers

8. Girls and Boys Clubs

- 3. Girl or Boy Scouts or similar organization
- 4. Church/religious children/youth ministries, choirs and activities
- 5. Sports or leisure activities for children/youth under 18 years of age
- 6. Teaching religious classes for children/youth under 18 years of age
- T. I will not frequent or loiter near the following locations:
  - 1. Parks
  - 2. Churches
  - 3. Playgrounds
  - 4. Skating rinks
  - 5. Sporting fields with children/youth activities
  - 6. Public swimming pools, sports facilities, or gymnasiums
- 7. Schools or child care facilities
- 8. Neighborhood centers
- 9. School bus stops
- 10. Arcades and amusement parks
- 11. Libraries
- U. I will be placed on Electronic Monitoring. I understand that I will be required to pay for this service.
- V. If I have been classified a Sexually Dangerous Predator by the Sexual Offender Registration Review Board, in addition to the above I will also comply with the following:
  - 1. My place of employment may not be within 1000 feet of any school bus stop, public and private park and recreation facilities, playgrounds, skating rinks, neighborhood centers, gymnasiums, and public and community swimming pools.
  - 2. I am to wear an electronic monitoring system for the entirety of my Parole period unless this condition is removed or suspended by the Parole Board. I will pay for monitoring services monthly.
  - 3. In addition to registering each year 72 hours prior to my birthday, I must update or verify all my registration information with the sheriff's office in my county of residence again six months after my birthday.
